

Building a strong and dynamic Caritas network at the service of the poor



his Activity Report presents the achievements of the Caritas Africa Regional Executive Secretariat during the year 2017.

The culmination of the year was the holding of the 2nd meeting of Bishops of Africa on "The organization of the service

of charity in Africa: the role of Bishops." This was made possible thanks to the commitment of the

Bishops of the Africa Region as well as to the financial and technical support received from the Government of the Republic of Senegal, Northern Sister Caritas Members and African Caritas Members, whose mobilization in terms of travel expenses contributions for some of their delegates was remarkable.

The 2nd meeting of Caritas Africa Partners at the end of the meeting of Bishops was also a great moment for the appropriation of the progress made by Caritas Africa

during the period 2016-2017 and to discuss the issues and challenges to be dealt with in 2018-2019.

The prospective evaluation of Phase 2 of the A2P-DIRO Programme raised questions that led Caritas Africa to reflect on the need for a coherent and inclusive Regional Strategy for Institutional Development and Capacity

Strengthening (IDCS), in order to materialize the commitments of the Kigali meeting (July 2016) with regard to the harmonization of approaches and tools for capacity strengthening and facilitation of the coordination of the IDCS initiatives in Africa to improve the impact of the interventions carried out by the different actors involved.

As a result, Caritas Africa commits itself, as from January 2018, to a participatory exercise to develop its Regional IDCS Strategy and, con-

sequently, to review its Global Strategic Framework for 2019-2023, together with its resource mobilization plan, necessary for its implementation, which will have to be submitted to the approval of the Caritas Africa Regional Assembly in May 2019.

The culmination of the year was the holding of the 2nd meeting of Bishops of Africa on "The organization of the service of charity in Africa: the role of the Bishops."

This exercise, which will extend throughout 2018, will involve moments of consultation, coordination and negotiation with the various stakeholders. This will require a certain availability of resources (human, financial and material). Caritas Africa is counting on the solidarity of both the Caritas Network and CIDSE insofar as the work that awaits us is the continuation of a journey that we began together, in communion, to build up, under the leadership of the Bishops a

strong and dynamic Caritas Network at the service of the poor, in our Region.

The Ecclesial Identity of Caritas

Caritas Africa's first Strategic Orientation requests the regional organisation to uphold the ecclesial identity of Caritas.

Nurturing a common organizational culture based on the teaching of the Catholic Church, in particular her social teachings

The Caritas Africa President participated in the Conference, organised by the Dicastery for Promoting Integral Human Development on the occasion of the 50th anniversary of the Encyclical *Populorum Progressio*, and which took place in Rome from 2 to 4 April, 2017. The aim of the Conference, entitled: "Prospects for service to integral human development: fifty

years since *Populorum Progressio*," was to study the theological, anthropological and pastoral perspectives of the encyclical, especially in relation to the labour of those one and all.

The Caritas Africa President and Regional Coordinator as well as three members of the Caritas Africa Regional Commission participated in several Caritas Internationalis meetings, namely: ExBo Meetings (Bishop President) and CI Representative Council meetings (all of them) held in Rome in May and November 2017.

Uphold the Ecclesial Identity of Caritas

Consolidate the Caritas spirit and structures at all levels of the Church in Africa

Caritas Africa actively participated in the Caritas Internationalis Ecclesial Identity working group meetings. This working group has produced a draft booklet entitled "Serving out of Love" which will be used as a guide for all those who are engaged in

Caritas at all levels. The booklet once approved will be published for the benefit of one and all



Furthermore, the above-mentioned book-let will serve as a useful tool in the course of induction sessions for newly appointed Bishops Presidents, Executive Secretaries/National Directors and Caritas Staff members as well as for various Caritas stakeholders.

Caritas activities and challenges were on the agenda of the ACEAC Episcopal Conference Standing Committee meeting that took place in Bukavu, Demo-

cratic Republic of Congo, in January 2017. This was to make the Church's hierarchy be aware of the work, challenges and stakes of Caritas in Africa and to get the Bishops attend the meeting to be held in September in Dakar.

To mark the 5th anniversary of the Kinshasa Declaration of Bishops, Caritas Africa organised the Second Meeting of Bishops in Dakar, Senegal from 18 to 20 September 2017. The theme of that meeting was: "Organising the Service of

The Caritas Internationalis Secretariat Team meetings were held in Rome, in May 2017, and in Saly, Senegal, in September 2017. These meetings offer an opportunity to the CI Senior Management Team to meet the Regional Coordinators and discuss with them on the best ways to move forward the CI agenda.

The Caritas Africa Regional Commission met twice during the year: in Antananarivo, Madagascar in March and in Pretoria, South Africa in October. The Regional

Charity: the role of Bishops." This event was well attended and saw the presence of 5 Cardinals, 20 Archbishops, 42 Bishops, Caritas Partners, Secretaries General and National Directors as well as guests from all the CI Confederation Regions. There were a total of 165 participants and 43 out of 46 Caritas Members in Africa were present.

Taking the thought of Pope Francis on the plane that brought him back from Colombia, on 10 September 2017, according to which Africa is not a land to be exploited but a friend to love, to help to grow, Bishops committed themselves to:

- "stand on the side of the communities and individuals, whose God given resources and means of livelihood, including their land, are under threat of exploitation by both internal and external interests;
- pay more attention to migration and refugee problems, to the consequences of political crises and natural disasters and, where appropriate, to work pro-actively upstream in order to better contribute to the eradication of the causes of poverty on a continent that is rich in its populations, especially its young people, its cultures and its natural resources:
- involve themselves in the preparation and participation in the next Synod of Bishops on the Young People who are the wealth of the Church and of the nation and to do everything possible to make them feel at home in the Church;
- create with their partners opportunities for these young people to contribute to their integral formation and to their Christian and citizenship growth;
- strengthen the participation of women and make visible their contribution to the development of our families and communities;
- encourage responsible leaders and Elites who serve the common good and constantly denounce those who are corrupt and who maintain the impoverishment of the masses as a strategy for the maintenance or conquest of power;
- progressively adapt their socio-pastoral structures to those of the Dicastery for Promoting Integral Human Development, according to the contexts of our particular Churches;

- contribute to the improvement of governance in their socio-charitable works, by adopting appropriate constitutive texts and by appointing competent and appropriate persons;
- integrate into the religious and priestly formation the systems of the social teaching of the Church and the minima of the principles of transparent management of the property of the Church belonging to the poor;
- develop a genuine synergy of action at the level of the continent, sub-regions (zones), Episcopal Conferences and dioceses with a view to productive ecclesial communion in the service of integral human promotion;
- strengthen fraternal solidarity with Sister Churches, interfaith collaboration and cooperation with civil society organizations for peace building and development in our regions, while respecting our Catholic identity and avoiding

us to be guided by contemporary ideologies."

This meeting was held thanks to the decisive support of the Senegal Government, the Bishops of Senegal, the CI General Secretariat, Caritas Sisters of Europe, Asia and North America and the Caritas Members of the Africa Region.

Enhance a culture of har-

monious collaboration and synergy between all socio-pastoral sectors of the Church in Africa

Caritas Africa invited Representatives from the SECAM and Religious Congregations to attend the Bishops meeting in Dakar, Senegal, in September 2017 to share their experiences in the work of charity and to shape the way to improve pastoral collaboration and synergy for a sustainable impact of this work. The SECAM was invited to attend as well the A2P-DIRO Program Stakeholders Assembly planned in November in Cotonou, Benin, but the meeting was postponed in January-February 2018.

At the country level, Caritas Africa MOs are working closely with other Church socio pastoral structures such as Justice and Peace, Education, Health, ... Commissions.





Institutional Development and Capacity Strengthening

Strategic Orientation 2

Reinforce Institutional Development

and Capacity Strengthening

The second Strategic Orientation calls upon Caritas Africa to reinforce the institutional development and capacity building of its member organisations in collaboration and with the support of Caritas Internationalis.

Develop a regional institutional development and capacity building strategy in terms of principle in collaboration and with the support of Caritas

The Caritas Africa Institutional Development and Capacity Strengthening & the Caritas Internationalis Management Standard (CA IDCS & CIMS) Reference Groups, set up since July 2016, have been active in 2017 and a Regional IDCS Strategy has been drafted. However, within the framework of the prospective evaluation of the

A2P-DIRO Programme, the need was also felt of developing an IDCS Regional strategy and updating in a participatory way the Caritas Africa Global Strategic Framework for 2019-2023. It was suggested that a Consultant be hired to support Caritas Africa in this process.



The Caritas Africa Regional Coordinator as well as the Chairperson (from Caritas Ghana) and a member (from Caritas Nigeria) of the Caritas Africa IDCS & CIMS Reference Group have also participated in CI IDCS Committee and CIMS Working Group meetings to share the experience and the work of Caritas Africa in this field in terms of process, outcomes, future strategies and how to continue the learning

process in Africa using Baobab, to feed reflections on documents to be produced by CI IDCS Department for trainings, etc.

There have also been discussions with several Sister Caritas Organisations on the best way to develop and support IDCS initiatives according to the outcomes of the Kigali Meeting in July 2016 which identified the following: harmonization of approaches and tools,

facilitating of CS initiatives coordination in the Region, self-assessment using the CI Management Standards; development of an Improvement Plan; and mobilising Partners to support the Implementation of the Improvement Plans of targeted Caritas Member Organisations.

Roll out of Caritas Internationalis Management Standards and ensure their compliance and monitoring

Caritas Africa representatives participated in training sessions organised by Caritas Internationalis in Bucharest, Rumania, for Coordinators, and in Vienna, Austria for Regional Evaluators.

Furthermore, the Caritas IMBISA Zone Coordinator participated in the Caritas Internationalis Rev-Com (Review Committee) Meetings and seven delegates from Caritas Africa were invited by the CI Management Standards Team to participate in an Evaluation Workshop which was organised in Singapore.

The implementation of the CI Management Standards in Africa is on-going. In order to speed up the implementation, peer support and peer learning are being encouraged to facilitate capacity strengthening.



The following Caritas Members are actively engaged in peer to peer accompaniment: OCADES Caritas Burkina and Caritas Senegal supporting respectively Caritas Guinea and Caritas Gambia & Caritas Guinea Bissau; Caritas Democratic Republic of Congo supporting Caritas Cameroon in December 2017 for the development of its Strategic Plan, and Caritas Congo supporting Caritas Central Africa, as part of the IDCS Project.



The trained Regional Evaluators facilitated consultations on CIMS for National Directors in Dakar, Senegal to get their opinion on the CIMS implementation in Africa.

As at the end of 2017, the situation is as follows across the Caritas Africa region:

- There are 38 Coordinators and 41 Evaluators, who have been trained in the CI Management Standards;
- 24 Member organisations have signed the CI Code of Conduct and the Code of Ethics;
- 5 Member organisations have had their self-evaluation report validated by the CI Review Committee;
- 12 Member organisations have submitted to CI incomplete self-evaluation reports;
- 26 Member organisations intend to submit their self-evaluation reports by the end of 2018.

Identify the needs of Member Organisations and develop a targeted accompaniment programme

There were also, during the year, on-going discussions between Caritas Africa and various partners to support concretely member organisations in Africa, especially those in need and in organisational fragile situations.

In collaboration with CRS/Senegal Country Office, Caritas Senegal and Caritas Africa pulled forces together to support Caritas Gambia through a participatory diagnosis leading to its improvement plan.

Through Caritas Africa, Caritas Norway has supported a project to strengthen the capacities of Caritas Niger. Thus, CaDEV (Caritas-Développement) Niger was able to gather more than 80 participants composed of staff of the CADEV Niger, volunteers of the Comité de Solidarité et de Développement (Solidarity and Development Committee) and pastoral agents of the Catholic Church to discuss the conclusions of the evaluation of the old Strategic Plan, the lessons learned and recommendations, to take ownership of the new Strategic Plan (2017-2021) and to amend the forms and printed materials developed during the Technical Agents meeting. The Administrative and Financial Manager and the Accountants met for two days to exchange on the CI Management Standards (CIMS)

in order to appropriate them. Technical officers from the National Office and the two Diocesan Offices were able to meet for the first time to provide/share their views and practices on projects and programs management.

With the financial support of *Secours Catholique* - Caritas France, Caritas Spain, Caritas Norway, CAFOD and the technical support from CI-IDCS Department, Caritas Africa has started a Pilot Capacity Strengthening Project (2017-2018) for three Caritas Member Organisations of the IMBISA Zone, namely: Caritas South Africa, Caritas Namibia and Caritas Swaziland with the participation of Caritas Lesotho as Zone Coordinator.

The project's specific objective for these three countries is to create an enabling environment for building up a learning, stronger and sustainable Caritas network, within the targeted countries.



A workshop was held in June, in Pretoria, South Africa, at the Padre Pio Spirituality Centre for participants from Namibia (3), Swaziland (2) and South Africa (27).



The learning path of the workshop, which was held in Pretoria, was as follows:




In conclusion, participants acknowledged that "the Human person is at the centre of all the activities of Caritas". As the "caress of the Mother Church to her children, her tenderness and closeness (Pope Francis), Caritas through compassion, unconditional love and self-less commitment, stands for the dignity of the human person created in the image and likeness of God. Their work for charity is inseparable from the promotion of justice, equity, solidarity and respect for all. They shared the conviction that "the Preferential option for the poor whom we are called to serve, accompany and defend (Pope Francis) is not a choice but a spiritual and moral

obligation. We believe that the encounter with the poor represents a call for personal conversion for each one of us and for all the faithful, leading to the building of an inclusive society, where each member contributes to the well being of all. We recognize



the need to let ourselves be evangelised by the poor, their experience of the suffering Christ (cf. *Evangelii Gaudium*), their humility and their generosity.





Participants valued the capacity of the poor to be protagonists of their own development and they seek to create the conditions for their full implication and participation in all that they will do.

The A2P-DIRO Programme

The Secours Catholique-Caritas France, together with 14 National Caritas Africa Member Organisations and the Caritas Africa Regional Secretariat joined forces to engage in a prospective evaluation and in on-going discussions to develop Phase 3 of the A2P-DIRO Programme to be transferred to Caritas Africa for its implementation.

Thus, the Caritas National Directors concerned met in Dakar in April 2017, while the Steering Committee met in September 2017, again in Dakar, to analyse and own the major findings of a prospective evaluation of the Programme, carried on by an independent Consultant.

Exposure visits

Exposure visits have proved to be very useful tools to strengthen the capacity of National Caritas members by providing concrete examples of good practices to their respective management and staff. Thus, in September 2017, after the meeting of Bishops in Dakar, two Bishops and the National Director of Caritas Cameroon visited Caritas Senegal to learn from the experience of the latter.

One Caritas Africa staff member (the Accountant) visited Caritas Niger with a special attention on financial aspects of multi-countries projects management in May.

In the frame of the pilot project mentioned above, in September 2017, the management of Caritas Guinea visited Caritas Burkina Faso with particular attention to the following objectives:

- 1. learn about experiences, strategies and constraints in managing a large national Caritas such as OCADES-Caritas Burkina;
- 2. work on resource mobilization and management strategies for a national Caritas, including techniques for the design and management of programs and projects of various kinds, with particular emphasis on the monitoring and evaluation system of activities of the General Secretariat and Diocesan Offices;



- 3. visit a diocesan Secretariat of OCADES-Caritas Burkina to better understand the synergy between the General Secretariat and Diocesan Offices in the implementation of projects and programs; and
- 4. draw together a strategy to support the OCPH-Caritas-Guinea by OCADES-Burkina in the framework of this institutional and technical capacity building initiative according to the needs expressed.

In terms of lessons learned from this visit to Burkina Faso, the delegation of OCPH-Caritas Guinea noted that:

- The commitment of Bishops at all levels is decisive for the establishment of a strong Caritas, well anchored in the community;
- Functional governance bodies, clear basic texts & Management Procedures Manual that takes into account Management Standards are essential for a credible Caritas, that manages its resources in a transparent manner.

Collaboration with other CI Regions and Actors on the IDCS issues

Caritas Africa has been working in close collaboration with Caritas Europa, Caritas MONA, Caritas LACar and Caritas Asia on the IDCS initiatives/ideas. It also got in touch with the International Council of Voluntary Agencies (ICVA) for the same purpose.



Poverty Eradication and Good Governance

The third Strategic Orientation of Caritas Africa calls upon the Regional organisation to contribute to the development of Church policies to address various forms of poverty in Africa. Some activities under this Strategic orientation were implemented with a support from Caritas Australia (CAKES - Caritas in Africa Knowledge, Exchange and Sharing -Platform, development of the RECS Project,...).

Caritas - World Bank pilot Initiative

A joint Caritas-World Bank pilot initiative focuses on the accompaniment of three Caritas Member Organisations in Africa, namely: Caritas Guinea, Caritas Niger and Caritas Central Africa. These Caritas Members need special attention given that they operate in fragile countries and, hence, have to face extremely difficult situations with very limited human and financial resources at their disposal.

A start-up workshop was held in Dakar, Senegal, and then it was followed by 3 other workshops at the country level (Conakry, Guinea; Niamey, Niger; Bangui, Central Africa) to reflect with different

stakeholders on the way to move this partnership ahead. Another workshop took place in Lomé, Togo, to develop an intervention strategy based on the principle of subsidiarity, complementarity, dialogue and consultation with governments and other civil society organisations and a participatory approach, which develops through the involvement and the empowerment of grassroots communities in all phases of project implementation, ongoing facilitation, enhancement of local capacities and skills.

This Strategy is structured around 3 pillars namely:

1. Strengthening people's resilience, with particular emphasis on improving access to basic social services (education, health), conflict prevention and management,

reception and assistance to refugees and internally displaced persons and support for their voluntary and dignified return;

- 2. Job creation and economic transformation, strictly related to the first orientation, with a specific focus on the integration (and/or reintegration) of women and young people into society;
- 3. Combating climate change, with special attention to food security and capacity building in Disaster Risk Management (DRM).

Two cross-cutting issues remain in the background of any action envisaged and thus integrate with the three pillars identified above:

- Inclusion and strengthening of youth and women's participation;
- Capacity building, in terms of internal human resources and Caritas organizations as members of civil society, or beneficiaries.

Survey on Caritas practices in measurement of poverty in Africa

This is a joint Secours Catholique – Caritas France and

Caritas Africa project linked with the new UN programme "Transforming Our World" by 2030 and building peaceful, just and open societies.

The study consists in identifying and analyzing tools and procedures used by Caritas Members in Africa to measure the populations' poverty level. The objective is to improve the quality of the answers / responses, projects and advocacy approaches implemented by the Caritas organisations.

22 out of 29 targeted National Caritas organisations have so far responded. The report will be presented in January 2018 during the A2P-DIRO Programme Stakeholders Meeting in Cotonou, Benin.



Survey on Caritas involvement in Microfinance

A survey has also been initiated on the commitment of Caritas Africa Member Organisations in Microfinance. Four members have responded. They are Caritas Burkina Faso, Caritas Senegal, Caritas Congo Asbl and Caritas Rwanda.

Commitment of Caritas in SDGs monitoring in Africa

Another survey has been carried in order to measure the commitment of Caritas Africa Member Organisations in the monitoring of the Sustainable Development Goal n° 2. Caritas Africa has received responses from 13 Member Organsiations.

Then, Caritas Africa obtained a financial support from the CI Regional Development Fund to implement a "Caritas Africa Mobilization Enhancement Support Project in Advocacy for the Promotion of the Right to

Food." Six countries were selected to be part of the PARCAP (Projet d'Appui au Renforcement de la Mobilisation de Caritas Africa dans le Plaidoyer pour la Promotion du Droit à l'Alimentation) which consists of the Capacity Strengthening on Advocacy techniques for the monitoring of the SDG2 implementation process.

Caritas Asia has invited Caritas Africa to share its experience in the Regional Workshop on Justice and resilience in the climate crisis, in December, in Bangkok, Thailand. A delegate from Caritas Ethiopia participated in this event to make a presentation on behalf of Caritas Africa on "Climate action, SDG and Food **Sovereignty"** to make the position of the Church and the work of Caritas in Africa well known on this topic.

Active participation of Caritas Africa

Caritas Africa has, all through the year, participated in several Caritas Internationalis Committees and Working Groups as well.

As an example, Caritas Internationalis, in collaboration with Catholic Relief Services and Cordaid, was looking to support CI Member Organizations in their health impact, specifically engaging with the Global Fund. As such, a meeting

was held in Geneva, Switzerland, on 26-27 September 2017 in order to strategize how to more fully engage in programming supported by the Global Fund. For that purpose, a survey was launched to help the co-organizers to better understand expectations, learn more about participant background and engagement with the Global Fund, as well as identify issues to be addressed in the meeting.

The following Caritas Africa Member Organisa-

tions namely Benin, Burundi, Côte d'Ivoire, Democratic Republic of Congo, Nigeria and Rwanda and the Regional Secretariat of Caritas Africa participated in the said meeting and are members of the Caritas Internationalis Task Force set up on the partnership Caritas - Global Fund. A working action Plan was developed at the same occasion.

The Global Campaign "Share the Journey" in the Region

Caritas Africa is actively participating in the Caritas Internationalis "Share the Journey" Global Campaign on Migration, launched by Pope Francis on 27 September 2017.



Taking advantage of the meeting of Bishops organized by Caritas Africa in Dakar, Senegal from 18 to 20 September 2017, the Global Campaign was launched in the region a few days ahead of the official launch in Rome.

It was a great opportunity to get all the Bishops present to adhere to this Global Campaign on Migration, an issue that calls for great attention all over the Africa Region.

Strengthening the resilience of vulnerable communities in Africa

Caritas Members in Africa have been committed in initiatives to strengthen the resilience of vulnerable communities in Africa. These include a project, benefitting from the financial support of Caritas Korea, will be implemented in 2018. It is entitled: "Resilience Enhancing and Capacity Strengthening on Food Security in Eastern Africa Countries (RECS)/ Kenya, Ethiopia, Uganda and South Sudan." It was developed to respond to needs identified in the CI SitRep on the Horn of Africa published in May 2017.

Caritas Africa has also been involved in disseminating information on calls for proposals and on initiatives/policies of the African Uniom (AU), the United Nations (UN), the World Bank (WB), the European Union (EU) as well as other organisations to encourage Caritas Members to be more committed in

the monitoring of their implementation or to submit their project proposals.

Caritas Africa and Caritas Europa have jointly engaged in Advocacy work in the frame of the AU-EU Heads of States Summit held in November 2017, in Abidjan, Côte d'Ivoire.

The CAKES Platform

2017 saw the finalisation of CAKES (Caritas in Africa Knowledge Exchange and Sharing) Platform (https://www.cakesplatform.info). The Platform has been presented in various Caritas Africa Forums, where many Caritas Africa members gave positive feedback that Platform will be a useful tool for information sharing and gathering. The platform has information on Caritas Africa members activities based on SDGS and documents repository as well as the 3W mapping of Caritas partners in Africa.

aritas in Africa Knowledge Exchange and Sharing platform (CAKES Platform), is a knowledge sharing platform which will allow Caritas Member Organizations to gather information, review, comment and version their contents and comments to enable unified collaboration, stimulate knowledge sharing and collective learning, exchange lessons learned and discuss insights on sustainable development.



Caritas members in Africa have a vast wealth of experiences and lessons learnt from their various regions. This information can now be shared and accessed on the CAKES Platform. The rich information gathered from partners, stakeholders and target beneficiaries for Caritas organizations in the Africa region will help members know each other and learn from each other in gross of

There are two main objectives of the CAKES Platform;

- i) Gather and map quantitative and qualitative data from National Caritas to provide information on the 3W's (Who is doing, What, Where)
- ii) Map information on Member Organisations, their strengths and areas of expertise, their weaknesses and areas they need support and capacity building.

These objectives of the CAKES Platform will help in creating synergy in implementation of the 2030 Agenda for Sustainable Development Goals (SDGs) based on the Social Teachings of the Church (STC) for Mutual Learning and Knowledge Sharing. It will also create a harmonized space for reflection and dialogue on the role of the Church on the implementation of the SDGs and 2063 African Union Agenda and to deepen the understanding of the STC in relation to the 2030 Agenda for Sustainable Development Goals (SDGs) in Africa. The Platform will strive to promote knowledge exchange and peer learning that contribute to fundamentally shaping our understanding and approaches towards strategies in the implementation of the SDGs and stimulate informal interaction and facilitate mutual learning. CAKES Platform will seek to manage, identify synergies and facilitate institutional innovation from knowledge generated from Caritas in Africa Member Organizations programs and projects. This will involve effective processes of capturing, distributing and utilizing internal and external knowledge to achieve the visions and missions of the Caritas organizations in Africa. Knowledge sharing can contribute to better development results as it is critical to organisations, building capacity and creating sustainable solutions for greater growth and equity especially with the Sustainable Development Goals. Sharing knowledge paves the way for a greater percentage of populations in developing countries to benefit from growth. Through our Sign

During this period, Caritas Africa incorporated two University Interns in Nairobi sub-office who greatly assisted in desktop research on partners mapping (3W mapping), information that was posted in the CAKES platform. This included the data received from the SAHEL region and from Cl on the Horn of Africa drought crises. The platform has incorporated Mailchimp, a web-based email service



programme for effective interaction with the platform and bulk communication on the platform and an interactive registration process for invitation and verification for acceptance to the platform and subsequent notification.

The platform is currently hosted by Amazon with monthly maintenance fee. It will be rolled out to the members in 2018 once it has been officially launched for members to start interacting with the platform.

COATNET Meeting in Brasilia

COATNET held its biennial meeting from the 10 to 14 November 2017 in Brasilia, Brazil. The main objective of the meeting was to enhance capacity of members in advocacy strategizing. The Network's advocacy strategy was developed step by step focusing on its thematic priorities: trafficking in maritime industry, trafficking for labour and exploitation, trafficking in crisis. There were joint sessions with the Anglican Alliance and Salvation Army representatives working on human trafficking



and looking for better cooperation among the networks. Participants have learnt about the experience of various religious groups and organizations in ending human trafficking in the Latin America and Caribbean region. This was an opportunity to promote networking and experience sharing among the participants including the use of the new Baobab and implementation of a COATNET database. Participants shared their projects and communication materials in a "market place".

Caritas Africa Representatives from Nigeria, Zimbabwe, Rwanda, Gambia, Mali, Tanzania, Uganda and Ethiopia attended the event.

The Catholic German Commission of Justice and Peace (CGCJP)



The CGCJP has invited Caritas Africa to attend its Conference in Arusha, Tanzania, from 16 to 18 November, 2017. Caritas Rwanda was appointed to attend, on behalf of Caritas Africa, the event, which focused on the following theme: "Promoting Respect in the Human Right to Health."

As a reminder, the Catholic German Commission of Justice and Peace has some years ago established a working group on "Human Rights and Cultural Traditions" in order to explore interactions between human rights and local cultural practices or traditional convictions. In this conference, the working group has focused on practical consequences of the relation between human rights and traditions in the "Human Right to the Highest Attainable Standard of Health".

Work for peace building and reconciliation and support the democratization process in Africa

CRS (Catholic Relief Services) has invited Caritas Africa to attend its Training workshop in Arusha, Tanzania, in September. Unfortunately, due to some logistics issues, their attendance was not possible.

of a response to drought in the most affected areas in the country. This work first consisted in gathering secondary data available, contacting several stakeholders such as the other actors, technical partners operating in the country as well as other members of the Caritas network, such as the dioceses.

After drafting the major orientations of the project, a validation workshop was convened to ensure coordination and national

proposal, using the new template from the Caritas Internationalis toolkit. This support from Caritas Africa, provided to one of its members, lasted 15 days and resulted in the finalization of an EA file, which was submitted to the CI network for a request for funding of 1 723 953 euros for the response to needs identified in 6 dioceses of Kenya. This project targeted a population of 97 943 people. At the end of 2017, the financial support received was 612 988 euros, that is 42,1% of the total budget.

Support to Caritas Congo (Brazzaville)

Caritas Congo (Brazzaville) has a long experience in the management of emergency projects but has never executed a project funded by the US Government. In partnership with the CRS program in the Republic of Congo and the Democratic Republic of Congo, Caritas Congo has benefited from USAID/OFDA funding for rapid Non-Food Item (NFI) assistance to 1 000 displaced families in the Pool region. USAID/OFDA is the Office of U.S. Foreign Disaster Assistance (OFDA), an organizational unit within the United States Agency for International Development (USAID).

For a financing of about US\$ 200 000 this project had to be implemented within 2 months in 3 Dioceses, namely: Kinkala,

In order to put all their assets on their side, Catholic Relief Services (CRS) and Caritas Congo negotiated with Caritas Africa to benefit from a special assistance, during a period of 2 months, for the implementation of this emergency project. The stakes were twofold: this project was an oppor-tunity to test Caritas' ability to work according to the management procedures used for US public funds; and it called upon Caritas to meet the quality standards required by CRS.

of the major stages of the project: targeting, selection of beneficiaries, exercise of accountability, compliance with Sphere standards. The main result was the early launch of an additional project in the same sector with the same partners with a larger objective.

Partners Meetings of Caritas South Sudan

The meeting was held in Rome on 22 and 23 March 2017. It was a space for sharing mutual concerns and issues related to fraternal cooperation with a focus on capacity building and writing of its Emergency Appeal (sharing information, meetings with

in-country partners, and contacts with diocesan Caritas members).

The meeting was also to look for ways to address the concerns and to find a long-term solution.

The meeting Objectives were as follows:

 To build mutual trust and confidence between Caritas South Sudan and the Member Organisations to implement the emergency response and the Recovery programs with close coordination;



- To mutually share the different strengths and weaknesses of Caritas South Sudan;
- To understand the aspirations of Caritas South Sudan to witness as the local church and find ways to help the local structure;
- To ensure coordination of support to Caritas South Sudan in the different fields of need, the Emergency Response and to see how Caritas South Sudan can collaborate with the Member Organisations to learn by doing;
- To initiate a coordinated Capacity Strengthening and Accompaniment Process through the new strategic plan; and
- To ensure the organisational and institutional sustainability of Caritas South Sudan.



Creation of a surge capacity in Africa for rapid response to emergencies in collaboration with Caritas Internationalis

Two basic training sessions in Emergency Preparedness and Response were held in Nairobi/Kenya in May 2017 and Grand-Bassam/Côte d'Ivoire in July 2017, with the support from Catholic Relief Services, Caritas Singapore, Caritas Spain and the CI WG on the Sahel.



The aim of these training sessions was to give the opportunity for the participants, to analyze their own practices and the way the disaster response is carried out.

The participants have been taken through an overview of the fundamentals to give a common understanding on the different concepts of Disaster and how the disaster happens and the integral disaster management process. This resulted in reflecting on how to reduce the effects by taking preventive measures. A special attention has been given to the Disaster Response as Church based organization.

By the end of these training sessions, the participants were able to:

Understand the importance of coordination in emergencies and the key tasks related to coordination;

Familiarise with the Emergency Response Framework, Protocol for CI Coordination in Emergency Response and Protocol for Sectoral Working Groups;

Understand the role of the Rapid Response, Emergency Appeal and Protracted Crisis Appeal funding mechanisms in the broader picture of CI funding options for emergency response; and

Use the CI Toolkit effectively.

Major results of these training sessions:

- 37 participants from 30 National Caritas Africa Member Organisations have been trained - that is 63%;
- 24% of the trained staff were women;
- One delegate from Caritas Jordan and three delegates from Caritas Haiti also attended the training sessions on behalf of the fraternal cooperation between the CI Confederation Regions.

Project PEOPLE (Preparing for Emergencies by strengthening Organisational Procedures, Learning and Exchange)

A project submitted to the European Commission in the framework of a consortium led by CAFOD will bring together Secours Catholique/Caritas France, CRS, Caritas Africa and CHS Alliance for its implementation. CHS, that is Core Humanitarian Standards for Quality and Accountability, is a direct result of the Joint Standards

Initiative (JSI), a project for which HAP International (Humanitarian Accountability Partnership), People In Aid and the Sphere Project have joined forces to improve coherence between humanitarian norms and make them simpler to use.



The main purpose of

the program is to strengthen the capacity of ten participating organizations in Liberia, Nigeria, Sierra Leone and Zimbabwe to prepare for and respond to humanitarian crises and strengthen their network and volunteer management systems. This is for a period of 24 months from April 2018.



The program will support three partners to initiate the process of becoming certified EU host organizations contributing to enhance European solidarity at an international level.

This program will make a difference to people affected by crises by enabling organizations to improve the quality and effectiveness of their humanitarian preparedness and response capacity. It will build partner capacity to develop and

manage an effective volunteer management systems and emergency preparedness by engaging community, office and international volunteers.

Learning and good practices from this program (on both strengthening organizations' humanitarian capacities and the role of volunteers in humanitarian action) will be widely disseminated.

Reinforcement through advocacy and communication initiatives of the visibility of Caritas work and its capacity in emergency response

Caritas Malawi and Caritas Mozambique are the 2 Caritas Africa Representatives to the CI Humanitarian Committee. They participated in the two CI Humanitarian Committee meetings in Rome in Italy and Bonn, Germany.

The first Committee Meeting adopted the Terms of Reference and operational plan for the group, and elected the leadership. Caritas Denmark and Caritas Mozambique are the Chair and the Vice-chair, respectively.

Humanitarian crises and CI Emergency Appeals were the main subjects discussed. This discussion was aimed to share and overcome challenges related to CI Emergency Appeals. Three main decisions/questions on this are:

1. CI Humanitarian Department recommendations should be addressed by the requesting Caritas before launching an Emergency Appeal.

- 2. How to overcome challenges linked to EA and institutional funds?
- 3. Pledges and transfer delay: What internal systems allow quick transfer of funds?

Emergency Appeals concerning Africa

In 2017, Caritas Internationalis has launched ten (10) Emergency Appeals in favour of the Caritas Africa region. The areas and countries concerned were the following:



Darfur in Western Sudan, Madagascar, Burundi, Democratic Republic of Congo, South Sudan, Rwanda, Kenya, Niger, Central African Republic and Uganda.

Encourage diversification of sources of funding to support Caritas/Church social and development programmes

A major difficulty for Caritas organisations at all levels as community, parish, diocesan, national and regional is to find ways and means of mobilising resources in a sustainable way: human, financial and material.



Ten National Caritas Member Organisations of the Africa Region contributed to the Caritas Africa Solidarity Fund in 2016 and in 2017. The total amount available for 2016 an 2017 was € 46 105. This includes an amount of € 15 876 left over from 2015. The table below lists the contributions received.



In order to build up the capacity of Caritas Members in Africa, a training session geared towards the Development of Resource Mobilisation was organised in Nairobi, Kenya from 2 to 4 October 2017 by Caritas Africa with the support from the CI GS. Through a participatory approach and with practical cases, the 28 participants (14 men and 14 women from 26 Caritas Member organisations) contributed to the development of the different modules and took note mainly of four fundraising tools namely good governance, effective communication, a good image of the institution and prayer.


































Networking and Communication

Ensure the visibility of Caritas work at all levels

Caritas Africa has, all through the year, been very active in promoting the free flow of information at all levels of the Caritas organisation, that is at regional, national, diocesan and parish levels.

In order to foster networking and communication, a training workshop was organised in Nairobi, Kenya, from 5 to 9 October 2017, with the support of CIMOs, including Caritas Spain, for the benefit of National Caritas Communication Officers, in order to reinforce their skills in communication strategy. There were 23 participants, comprising 10 women and 13 men from 20 Caritas Africa Member Organisations.

The aim was to contribute to a better visibility, at all levels, of Caritas activities in communities, parishes and dioceses, as well as at national, even continental and international levels. The workshop was organized by Caritas Africa in collaboration with Caritas Internationalis.

Caritas Africa aimed at providing the Caritas Africa Communicators Team (CACT) with the capacities, tools and techniques necessary for the optimal functioning of the communication units or de-

partments of their respective Caritas, so that they be more effective in fulfilling their | is distributed free of charge not only in Africa but all over the world. It is also available missions in the service of the most deprived members of society.

This included encouraging the Communicators of these national Caritas Members to actively use various channels of communication and to build credible sources of information within and beyond the Caritas Confederation; to make full use of the means of mass communication, the Internet and social media to communicate with their respective publics; to ensure that Caritas is firmly rooted in the Church in Africa.



Caritas Africa is also present within the social media. Its Facebook and Twitter pages are regularly visited and provide much facilities to all those stakeholders who want to network with the organisation.

Caritas Africa also contributes to the development of the Caritas Internationalis Baobab Platform and sensitizes its members to register on that platform and take advantage of the networking facilities offered.

The 2016 Caritas Africa Annual Report was published in the three Caritas Africa working languages: English, French and Portuguese.





Effective liaison and presence in Regional Civil society platforms and fora; collaboration with African and International institutions with presence in the Region

In the frame of meetings held in 2017, the Caritas Africa Bishop President and/or the Executive Secretary visited several Caritas Africa members including the following: Caritas Senegal, Caritas Niger, Caritas Central Africa, Caritas Madagascar, Caritas Benin and Caritas Côte d'Ivoire.

They also visited other CI Regions: Caritas MONA, on the occasion of the Caritas MONA Regional Conference and Partners Meeting in May 2017 in Amman, Jordan; and Caritas Asia, to participate in its Conference & Partners Meeting in June 2017, in Bangkok, Thailand.

The Caritas Executive Secretary also participated in the RECOWA/CERAO Zonal meeting which was organised in Dakar, Senegal in September 2017 and which saw the participation of 11 out of the 15 National Caritas organisations of that Zone.

The Lusophone Caritas Forum was organised in Praia, Cape Verde, in October 2017 and regrouped Lusophone Caritas Members from Asia, Europe, South America and Africa.

Note: This balance of 148 278 euros is due to the late arrival of certain supports (hence the postponement in 2018 of certain activities), thanks to the savings realized by Caritas Africa following the effort made by a significant number of African Caritas organisations to cover the travel expenses of their delegates. It should also be noted that 12 delegates from Caritas organisations of the Sahel were taken over by the GTCIS during the emergency training.





In 2017, Caritas Central Africa has again managed to organize the great Agricultural Fair of Bozoum, created in 2004 to encourage farmers and cooperatives. It is known as the "Feast of the Proud Peasant"!

Caritas believes that there is no Peace without development and hence continues to encourage the efforts of women and men of good will, who are convinced that only work, patience and passion can build a person's dignity.

The Fair is an exhibition space (to highlight the "beautiful" face of agriculture) as well as a space to sell agricultural products: in 2013, before the war, sales reached Euro 84 000! According to estimates, sales in 2017 have reached Euro 22 900.
